# AT-A-GLANCE RESOURCE OPTIONS

**Confidential** means that the information disclosed by the student, verbally or in writing, will be maintained in a confidential manner to the extent allowable by law and will not be disclosed to anyone outside the office to which it is reported without the student’s consent. Consent may not be required, however, in situations involving suspected child or adult abuse or neglect, court orders or subpoena or danger to self or others.

**Private/Non-Confidential** means that information disclosed by the student will be considered private but not confidential. For example, reports of sexual misconduct must be shared with appropriate administrators and the Title IX Coordinator so that the University can take necessary action to ensure the safety of the University community.

**Confidential and Non-Confidential** means that this office has two types of designated staff. One who is a Confidential Advisor (see definition above) and one who is a Non-Confidential Advisor (see definition above). When seeking help from offices with two types of dedicated staff, identify which employee type you wish to speak to when setting up an appointment.

# UIC SEXUAL MISCONDUCT POLICY (KEY POINTS)

Knowing or experiencing sexual abuse can be confusing and difficult to handle. Learning what to do in the event that you or someone you know is a victim of sexual abuse. Here is a summary of the UIC Sexual Misconduct Policy and guidelines. To see the complete guide please visit: [sexualmisconduct.uic.edu](https://sexualmisconduct.uic.edu).

UIC is committed to providing an educational and work environment that is free from all forms of sex discrimination, sexual violence, and sexual and gender-based harassment. UIC prohibits and will not tolerate sexual misconduct of or by students, employees, patients, or visitors. UIC will take prompt and fair action to eliminate such conduct, prevent its recurrence, and remedy its effects through interim support measures and accommodations, equitable investigations, and disciplinary processes.

Employees and students in violation of this policy may face sanctions up to and including termination or expulsion. The Office for Access and Equity, through its Title IX Coordinator, has the authority to conduct investigations, and refer cases in accordance with the relevant University policies for students, employees, patients, or visitors.

## **You Are Not Alone**

You Have Support. We want you to know that what happened is not your fault and whatever you did to survive was the right thing to do. UIC has a number of offices that respond to students who have experienced sexual assault, sexual harassment, dating violence, intimate partner violence, and stalking. There are several confidential and private/non-confidential campus and community resources to assist you and provide support.

## **Student Victims and Survivors**

UIC is committed to providing support and assistance to all victims/survivors of sexual misconduct. Once informed, appropriate University offices will work to assist with and provide guidance about reporting to law enforcement, obtaining counseling or health services, making academic and administrative accommodations, and filing a complaint with the student conduct process.

## **Know Your Rights**

Survivors of sexual assault, dating violence, intimate partner violence, and stalking have a number of different options available for reporting sexual misconduct and seeking help and support.

# STUDENT VICTIMS AND SURVIVORS (KEY POINTS)

## **Get Safe and Get Help**

Immediately after a sexual or physical assault or stalking, get to a safe place as soon as you can. Consider the following to assist you with getting safe and getting help:

- Call the UIC Police directly at (312) 355-5555
- Use any of the Startel Alarms (tall blue poles with a big red button), which are located across campus
- If you are in a residence hall, inform a Campus Housing staff member
- If you are off campus, call 911

Tell someone you trust what happened.

## **Get Medical Attention**

Getting medical attention is very important for addressing the physical consequences of any type of assault, even if you do not wish to press charges or collect evidence.

If you can, seeking medical attention within 24 hours of a sexual assault is most ideal for medical and preventative treatment. Survivors of sexual or physical assault can have health issues that include: bruising, cuts, abrasions, internal injuries not readily apparent or broken bones.

## **Report a Sexual Misconduct**

The University strongly encourages the prompt reporting of sexual misconduct to the appropriate University officials. The report may be made either by a person who believes they have experienced sexual misconduct; or a person who has information that sexual misconduct may have occurred.

The University encourages anyone who believes they have experienced a crime or has knowledge of a crime to make a report to the UIC Police Department at (312) 355-5555.

If a crime took place on non-University property or was reported to another law enforcement agency, students are still encouraged to contact the UIC Police for assistance.

# STUDENT CONDUCT PROCESS (KEY POINTS)

## **Student Conduct Complaint**

Any member of the University community can file a complaint regarding student misconduct with the Office of the Dean of Students. Students have the right to file a complaint related to sexual misconduct in conjunction with or after the completion of a University Title IX investigation.

## **Student Rights**

The complainant (reporting party) and the respondent (alleged party) have similar rights throughout the student conduct process. Refer to Student Expectations and Rights for complainants and respondents.

## **Multiple Student Respondents**

In reviews of incidents involving more than one student respondent, the student conduct administrator in the Office of the Dean of Students will determine whether the reviews for each student are conducted separately.

## **Sexual Misconduct Hearings**

Sexual misconduct hearings are conducted as described in the Student Disciplinary Policy. A staff member in the Office of the Dean of Students will meet separately with the complainant and the respondent to discuss the incident, explain the student conduct process, and answer any questions. The complainant and the respondent are informed about the hearing procedures and the opportunity to present witnesses and other relevant information and to have a support person and advisor participate in the hearing.

If the complainant reported the sexual misconduct to the UIC Police and a report was generated that indicates a possible violation of the UIC Student Standards of Conduct occurred, the complainant can choose to be a co-complainant with the UIC Police or serve as a witness during the student conduct hearing. Accommodations can be arranged for participation in the hearing such as allowing the parties to participate in the hearing via electronic means.

## **Testimony and Evidence**

During the presentation of the evidence segment of the student conduct hearing, the Title IX Coordinator or designee will present a summary of the investigation. The complainant, student respondent, and student conduct board members will have an opportunity to ask questions related to the investigative report.

In cases concerning accusations of sexual misconduct, past sexual history of any involved party will not be admitted in evidence or testimony unless directly relevant to the matter under consideration.

If the respondent declines to present information on his/her own behalf, this will not be construed as an admission of responsibility. If the complainant declines to participate in the student conduct hearing, this will not be construed as evidence that favors the respondent.

## **Standard of Proof**

The outcome of a student conduct proceeding will be made using the preponderance of the evidence standard. The preponderance of the evidence standard requires the student conduct administrator and/or the student conduct board to determine whether or not it is more likely than not that sexual misconduct occurred.

## **Sanctions**

The sanctioning process for sexual misconduct is designed to eliminate the misconduct, prevent its recurrence, and remedy its effects, while supporting the University's educational mission and Title IX obligations. Sanctions may also serve to promote safety or deter students from similar future behavior. Sanctions will take into consideration the gravity of the student's actions and the student's entire conduct records at the University and will be designed to (1) hold students accountable for their actions and the resulting or potential consequences of such actions, and (2) protect the safety of the university community.

Sanctions may include, but are not limited to, one or more of the following: Warning, Developmental Sanction, Recommended Counseling, Restitution and Fines, Failure or Grade Modification, University Probation, Suspension, Dismissal, Expulsion. A full description of the sanctions is included in the Student Disciplinary Policy.

### **Notification of Hearing Outcome**

A written notice will be sent to both parties informing each student about the outcome of the student conduct hearing as determined by the responsible hearing committee. Notices will be sent to the students via email to the students' official university email address, U.S.P.S. mail to the students' address located in the official records held by the Office of Admissions and Records, or hand delivered to each student.

### **Appeals**

The respondent will be informed about whether the University found the respondent responsible for the alleged misconduct, any sanctions imposed, and information regarding the appeal process. The respondent will not be notified of the remedies offered or provided to the victim.

The complainant will be informed as to whether or not the University found the respondent responsible for the alleged misconduct, any sanctions imposed on the respondent, and other steps the University has taken to end the sexual misconduct, eliminate the hostile environment, prevent its recurrence and, as appropriate, remedy its effects. The written notice will also provide information on the appeal process.

Both the respondent and the complainant have the right to appeal the hearing outcome within five days after the date of the issuance of the decision. Both parties will receive written notification, simultaneously, of the final determination of the appeal committee. The appeal process is described in the Student Disciplinary Policy.

### **Status of Student Respondents**

In most cases, the status of a student respondent will not be altered, and disciplinary sanctions will not be initiated until completion of the investigation, the student conduct hearing, or an appeal. Interim measures may be initiated whenever there is evidence that a student or student organization may pose an ongoing threat (1) to the safety or well-being of one or more members of the University community, (2) to property within the University community, (3) or that disrupts or interferes with normal University life or functions. Refer to Interim Interventions for more information.

Administrative holds affecting registration transactions, posting of degrees, and students' ability to acquire copies of their transcripts may be placed when students fail to fulfill terms of their disciplinary obligations. Such situations may include failure to respond to a written notice indicating a required meeting with a designated student conduct official and failure to complete disciplinary sanctions by an established deadline. This restriction normally will remain in effect until disciplinary obligations are met or adjudication of the matter is complete.

When the outcome of a student conduct action is suspension from the University, the student will not be allowed to register for classes during the period of the suspension. The restriction will not be removed, and the student will not be allowed to register until the stated period of suspension has expired and all disciplinary obligations are met.







# OVERVIEW OF SURVIVOR RIGHTS

## Your Campus Rights

- To have any and all reports of sexual misconduct treated seriously and to be treated with respect and dignity by University officials.
- To file a complaint about sexual misconduct with the University and/or receive assistance with notifying campus or other police departments.
- To request an interim intervention which may include a change in academic and living situations after an alleged sex offense and to be informed in a timely manner of available academic, living, and administrative options.
- To be informed in writing about campus and community resources for victim assistance and advocacy, counseling, and other resources and options for victims of sexual misconduct.
- To receive information on the University's responsibility to make a confidential report, required by the Clery Act, for the purposes of tracking campus crime.
- To be informed of the criminal and campus processes to investigate reports of sexual misconduct (e.g. Title IX investigations, student conduct process) and about the options to participate in these processes.
- To inspect documents and/or relevant information gathered as part of the investigation and the student conduct process (though medical/mental health information may be kept confidential). A request to inspect documentation or evidence should be directed to the investigator or student conduct official at any time during the process. Requests must be presented in writing at least two working days in advance.
- To have the same rights as the student respondent to have witnesses and an advocate or advisor present during an investigation and student conduct proceedings and to have accommodations made that minimize face to face contact with the student respondent.
- To be informed of the initial outcome, in writing, of an investigation and/or a student conduct proceeding involving sexual misconduct and the right to appeal the outcome and receive written notification of the final determination.
- To be free from undue coercion or retaliation from any member of the University community resulting from a report of sexual misconduct.
- To receive Translation Services, from the UIC Office of International Services, at any point during the process.

## Your Legal Rights

- Victims of violent crimes have constitutional and statutory rights. These rights apply whether the offender is an adult or a juvenile. Violent crimes include homicide, felony assaults and batteries, kidnapping, sexual assault and abuse, arson, domestic battery, misdemeanors that result in death or great bodily harm, stalking, driving under the influence, and violations of orders of protection and civil no contact orders. **Some of these victims' rights become rights only if you request them. These rights are listed in red.**
- You should be treated with fairness and respect for your dignity and privacy throughout the criminal justice process.
- You can ask the police for information about the status of the investigation. The police must notify you if they reopen a closed case.
- You can hire an attorney to represent you.
- You have the right to have a translator or sign language interpreter for all court proceedings.
- You may have an advocate or support person with you in the courtroom, subject to the rules of evidence.
- **You have the right to be notified of court proceedings and when proceedings are canceled or rescheduled.**
- You can attend court proceedings.
- You can attend the trial, unless the court finds that your testimony will be affected if you hear the testimony at trial.
- **You can be notified when the offender is released from custody.**





### **After Charges Are Filed**

- You have a right to a prompt disposition of the charges after the arrest of the accused.
- You can get information about the charges from the prosecutor.
- You can get information about victim services, social services and financial assistance from the prosecutor.
- The judge must consider your safety when setting release conditions for the offender.
- The prosecutor can assist you in having your property that was seized by police returned to you as soon as possible.
- The prosecutor can communicate with your employer to minimize your loss of pay and benefits when you attend court proceedings.
- The prosecutor will tell you if there is a secure waiting area during court proceedings so you are not near the offender or the offender's family.

The UIC Police Department, in full partnership with the University and its surrounding communities, is committed to the safety and security of the campus and its neighborhoods, so to create the most enriching academic environment and quality of life for all UIC students, faculty, staff, and visitors.

We will strive to empower and develop our sworn officers and civilian support personnel to achieve excellence through respect, service, preparedness, engagement, communication, and trust. Our commitment to transparency, community policing, collaboration, innovative practices and on-going training will ensure the highest professional standard of public safety service. Our goal is to foster safety and security and create an environment for continuous growth and intellectual advancement for all.

### Our Services

- When an individual files a complaint with the UIC Police, a report will be generated, and a discussion of various options and resources will be provided to help determine further action.
- If the individual wants to press charges, a police report is created, the individual is informed about the criminal process and the police conduct a criminal investigation.
- If the police determine that the elements of a crime have been met, and the investigation rises to the level of a felony offense, the case will be forwarded to the Cook County State's Attorney Office, who will determine if those offenses will be prosecuted. A copy of the police report may also be submitted to the Title IX Coordinator and/or the Office of the Dean of Students.
